Joint Statement of Civil Society Organizations to the Committee of the Whole II

Thank you, Madame Chairperson,

Distinguished Delegates,

It is my honour to convey to you the Joint Statement of Civil Society Organizations. Our Statement reads as follows:

"We, 18 civil society organizations gathered in Bangkok on twenty-third April 2013 in the Informal Session of Civil Society Organizations on the Working Group on the Asian and Pacific Decade of Persons with Disabilities, 2013 to 2022, and decided on which civil society organizations would participate in the Working Group on Asian and Pacific Decade of Persons with Disabilities.

We deeply appreciate the agreement reached by the High-level Intergovernmental Meeting on the Final Review of the Implementation of the Asian and Pacific Decade of Disabled Persons, 2003 to 2012, held last year in Incheon, Republic of Korea, to include, on an equal basis with ESCAP members and associate members, civil society organizations in the membership of the Working Group.

In this regard, we are pleased to present to the Commission in alphabetical order the following 15 civil society organizations which are ready to serve as full members of the working Group:

We wish to record our gratitude to the following three sister civil society organizations that have offered to extend, in their capacity as observers, full support to the Working Group. We shall endeavor in the Working Group to articulate the concerns of the many civil society organizations that contribute to disability- inclusive development in the ESCAP region, but are not member of the Working Group.

We reaffirm our strong commitment to working closely with Government partners towards the effective implementation of the Incheon Strategy.

The Incheon Strategy is the Asian and Pacific region's pioneering contribution to the Highlevel Meeting on Disability and Development, to be held in New York on 23rd September
